POSITIVE TEST- POST RACE

Mass 205 CMR 3.29, ARCI. Trainer Nancy Bauer was trainer of record for the horse BILL BAUER, who raced at Plainridge Park Racecourse on 05/12/2026 in Race 10. On 05/28/2026 Industrial Laboratories reported the analysis of blood sample E673765 taken from the horse BILL BAUER. They identified the finding of Betamethasone in Blood at 35.8 pg/mL. The measurement uncertainty of the method is 1.3 pg/mL at the threshold of 10 pg/mL. Betamethasone is a Class 4C. After being notified of the finding trainer Nancy Bauer waived her right to both a split sample and a formal hearing. As a result of the violation, she is hereby fined the sum of \$1,000.00. In addition, the horse BILL BAUER finished 1st and is disqualified and unplaced. The purse monies won or \$6,000.00 is hereby forfeited and ordered returned for redistribution. All fines are payable within 48 hours of imposition.

PA Code Title 7-185.7(a)203.22(a)(b) 401.2(a)(1)(2) 401.3(a)(b) 401.46 Owen Eiler was the trainer of the horse STRETCH THE LINE for the 10th race on November 14, 2025 at Harrah`s Philadelphia Racetrack. Blood samples drawn (post race) from STRETCH THE LINE were tested and found to contain Darbepoetin Alpha (DPO) this is a class 1 drug with an A penalty(one year suspension and \$10,000 fine). As the trainer, Mr. Eiler is responsible for the positive test. STRETCH THE LINE finished 3rd and is disqualified and placed 7th. All purse money earned from this race by STRETCH THE LINE (\$960) must be returned within 10 days of this ruling. Mr Eiler is fined \$10,000 (fines are due within 10 days of ruling). Mr. MacDonald used inappropriate and threatening language to the judges and the race secretary who was present during this altercation. The judge`s called for a hearing in the matter on May 30, 2026. Following the hearing, the judge`s issued a decision. Therefore, Mr. MacDonald has been suspended from participation in racing for 180 days. The suspension is to begin on 6/1/26 and end on 11/27/26.

EXCESSIVE OR INDISCRIMINATE USE OF WHIP

Rule 4117.8(D)(2);4117.8(H)(2); 4117.8(H)(6). Driver Dan Rawlings is hereby assessed a fine of \$8,000.00 and suspended from driving for 120 days for using the whip in an excessive manner, using the whip more than 3 times in succession without giving his horse time to respond, while driving ICARUS FALLS N, in the 6th race on August 11, 2025, at Monticello Raceway. (This violation constitutes a 7th violation in this category in a 365-day period.) Further, giving consideration to the frequency of violations and abject failure to comply with the NYS Gaming Commission whipping rules, pursuant to NYSGC rule 4117.8(H)(6), the Judges have referred Dan Rawlings to the Commission for a determination as to his character and fitness to hold a racing license in the State of New York.

Status as of 5/18/2026 - Subsequent Ruling - The Commission met on May 18, 2026, and after consideration and due deliberation of the entire record, adopted the Hearing Officer's findings of facts but modified the Report as to the conclusions of law and the penalty, given the facts and circumstances of this matter including that the care of the horses is fundamental to the responsibility of the Commission, that excessive whipping of equine athletes 47 times indicates carelessness towards and willingness to violate the rules of the Commission, that such attitude of Respondent is inconsistent with an attitude a trainer licensed by the Commission should have and with the best interest of racing in general, and that the nature of Respondent's conduct bears on his fitness both as a trainer, whose responsibilities involve the care of horses, as well as on his fitness as a driver. THEREFORE, based upon the entire record (including, without limitation, the evidence specifically relied upon by the Hearing Officer), the Report, and the findings adopted by the Commission, it is hereby ORDERED, that related to matter MO 22-2025, Respondent's Commission issued occupational license, including all rights to participate in harness racing in New York, is revoked, effective May 18, 2026, with the period of August 28, 2025 to May 17, 2026, representing a suspension of Respondent's Commission-issued occupational license; and Respondent, as a patron or otherwise, hereby expelled from New York pari-mutuel and harness racing on or off any Commission-licensed race tracks; ORDERED, that pursuant to Notice Number MR 32-2025, Respondent shall pay a \$4,000 fine within 30 days of Respondent's receipt of this notice, which is deemed to have occurred five days after the date of this notice, pursuant to New York's State Finance Law § 18. Any failure to make such payment by such date will

result in the assessment of interest or a later payment charge and may result in a charge to cover the cost of processing, handling, and collecting such debt
