FAILURE TO PASS THE BREATH ANALYZER TEST

Trainer Jamie Bozman was randomly selected for breathalyzer testing on June 28, 2026 at Ocean Downs. After taking an initial breathalyzer test and a second confirmatory test, both results showed a blood alcohol concentration (BAC) that exceeded the limit permitted under Maryland Racing Commission regulations, in violation of COMAR 09.10.03.06(1). Consequently, Ms. Bozman is hereby assessed a fine of Five Hundred Dollars (\$500.00). The fine assessed must be paid within ten (10) days of the issuance of this ruling. Failure to submit payment within this period shall result in the full suspension of the Maryland Racing Commission licensee and will remain in effect until full payment is received.

POSITIVE TEST- POST RACE

Mr. Randy Crisler was the listed trainer of #1 JK's Shining Star who was in the 6th race at Oak Grove on 3/23/2026. Sample E620280 collected and sent to Industrial Laboratories confirmed on 4/8/2026 a level of 12.1 ng/mL which is over the allowed 5 ng/mL violating 810 KAR 8:025 Section 2 – 1. Mr. Crisler requested a split sample that was sent to UC Davis on 4/29/2026. Report dated 6/9/2026 for sample E620280 confirmed a level of 14.8 ng/mL over the allowed 5 ng/mL. Having met with the Board of Judges and considering the timing of the races and unknown knowledge of previous overage the Board of Judges to find mitigating circumstances and issue a fine of \$1,500 (One Thousand Five Hundred Dollars). Furthermore, #1 JK's Shining star has been disqualified 1st placed 9th and the

purse of \$5,500 (Five Thousand Five Hundred Dollars) has been ordered to be returned and redistributed.

FAILURE TO OBTAIN PROPER LICENSE

PA Title 7-203.11(e) Mark W Eaton has failed to complete licensing requirements in PA for 2026. CHAKRA raced on 3/4/2026 at Pocono Downs under a 30 day owner affidavit. Mr. Eaton was fined \$50 and is suspended indefinitely beginning 6/3/2026 and will remain suspended until the fine is paid and all licensing requirements have been met.

Status as of 6/27/2026 - Subsequent Ruling - Amendment to Ruling #26082PD. The effective start date for Mark Eaton's suspension as initially issued under Ruling No. 26082PD has been adjusted pursuant to this amendment. An administrative review has confirmed that Mr. Eaton was not properly notified of his suspension until June 12, 2026. Consequently, Mr. Eaton's suspension has been determined to have officially commenced on June 12, 2026. Additionally, Mr. Eaton has since satisfied all PA licensing requirements and was restored to good standing on June 13, 2026.

Mass 205 CMR 3.11 (10). USTA Rule 22.00 (S22.05). On 06/12/2026 trainer/owner Mark Eaton was found to be under suspension as of 06/03/2026 by the Pennsylvania Racing Commission for failure to obtain a proper license and would remain indefinitely suspended until the fine is paid and all license requirements were met. The initial infraction date was 03/04/2026. During the suspension period Mr. Eaton entered and raced horses on 06/04/2026, 06/08/2026, 06/09/2026 and 06/11/2026 at PRC, totaling a number of five horses. There were an additional three horses he entered to race on 06/15/2026 and 06/16/2026 at PRC, that were scratched by the Board of Judges on 06/12/2026. In light of the fact Mr. Eaton entered and raced horses during his full suspension in Pennsylvania; this made him ineligible to participate at PRC. A hearing was conducted on 06/15/2026. As a result, Mr. Eaton is hereby fined the sum of \$300.00. In addition, the horses that participated on 06/04/2026, 06/08/2026, 06/09/2026 and 06/11/2026 are hereby disqualified and all purse monies earned are ordered forfeited and returned for redistribution. The total

amount forfeited is \$18,240.00 and must be paid within 10 days of ruling. The \$300.00 is payable within 48 hours of imposition. Purse monies forfeited are payable to Plainridge Park and the fine payable to Comm. of Mass. This ruling is appealable within 10 days of ruling.

On June 22, 2026, a search of Barn D was conducted at Northfield Park. During this search, three needles attached to syringes were found in the tack room assigned to trainer Keith Kash, Jr. Mr. Kash, Jr, represented by his attorney, had a hearing with the judges at Northfield Park on June 28, 2026. After considering all testimony and evidence he is hereby fined \$1,000, suspended for 365 days, and referred to the commission for further action. (First offense in the last 365 days). If this ruling is not appealed, the penalty will be reduced to \$1,000 fine and 180-day suspension (with the remaining 185 days stayed, pending no further violations in the next 365 days). This is an action that is against the best interests of racing. O.S.R.C.3769-18-07(A); 3769-2-26(A)(4),(10); 3769-2-99; 3769-17-30(B); 17-33(A) Mr. Kash, Jr is barred from all grounds governed by the OSRC during his suspension. Any horses under his care that he wants to transfer to another owner or trainer must be approved by the judges in the state of Ohio. The fine must be paid by July 9, 2026. Mr. Kash, Jr has 48 hours to appeal this ruling.

MEDICATION PROCEDURE VIOLATION

71 IAC 5-3-2(a)(2),(b), 8-1-1.5, 8-1-2(a); 8-1-5(1),(2),(5),(8) 7Sample No. E682792 taken from the horse GW STRYKER following the conclusion of race 7 on April 22, 2026 at Hoosier Park tested positive for Furosemide (Lasix). GW STRYKER was listed as a non-Lasix horse in the program and a review of the Lasix sign-in sheet for April 22, 2026 shows that the horse did not receive Lasix from an IHRC licensed veterinarian assigned to administer Lasix on that day. As trainer of record Suhein Matos is in violation of the IHRC trainer responsibility and medication rules. Ms. Matos waived her right to split sample testing. Ms. Matos also waived her right to a hearing accepting the following penalties: For this violation Ms. Matos is fined \$500.00 which is due within seven days of this ruling. Purse of \$5,000.00 to be returned and redistributed as follows: #1 DRAMA CRITIC finished second placed first #4 FOX VALLEY BOXER finished third placed second #9 ODDS ON LIL ROCKER finished fourth placed third #8 SPECIAL PETE finished fifth placed fourth #3

After considering all testimony and evidence she is hereby fined \$1000 and suspended 365 days (First offense in the last 365 days). If this ruling is not appealed, the penalty will be reduced to \$1000 and 180 days(with the remaining 185 days stayed pending no further violations in the next 365 days). Further penalties may be imparted by the OSRC. This is an action that is against the best interest of racing. O.S.R.C-3769-18-07(A)3769-2-26(A)(10)3769-2-99 17-30(B)17-33(A) Ms. Merriman is barred from all grounds governed by the OSRC during her suspension. Any horses under her care that she wants to transfer to another owner or trainer must be approved by the judges in the state of Ohio. The fine must be paid by 7/8/26.

CONDUCT DETRIMENTAL TO THE BEST INTEREST OF HORSE RACING

Mr. Matthew Wilson and his legal counsel appeared before the Board of Judges on 6/29/2026 at 10:30 AM. After hearing testimony and presented with evidence the Board of Judges do find that Mr. Wilson violated 810 KAR 3:020 Section 15 – 1 – Q by engaging in conduct detrimental to horse racing. Specifically, the Board of Judges found that Mr. Wilson was under the direction and control of an individual deemed ineligible to obtain a license by the KHRG. Additionally, Mr. Wilson made false statements during investigative proceedings and interviews jeopardizing the integrity of racing at tracks under the jurisdiction of KHRG. Mr. Wilson is hereby suspended 365 (Three Hundred Sixty-Five) Days and issued a \$1,000 (One Thousand) Dollar Fine. During his suspension Matthew M. Wilson is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing and Gaming Corporation. Entry of all horses owned or trained by Matthew M. Wilson is denied pending transfer to persons acceptable to KHRG judges. Mr. Wilson is required to appear before the License Review Committee of the Kentucky Horse Racing and Gaming Corporation for any future license consideration.
