POSITIVE TEST- POST RACE

Mr. Leslie Burton is the listed trainer of #8 Giganthor who was in the 5th race at Oak Grove on 4/7/2026 and subject to post race testing. Sample E620379 that was sent to Industrial Laboratories confirmed on 5/4/2026 Suzetrigine in the blood which is listed as a Class A medication under ARCI guidelines, violating 810 KAR 8:020 Section 1 – 2 – B. Mr. Burton requested a split sample, that was sent on 5/27/2026 to EQIAS Labs. Their report dated 6/17/2026 confirmed Suzetrigine in the blood. In the absence of substantial evidence to the contrary, a trainer shall be responsible for the presence of a prohibited drug, medication, substance, or metabolic derivative, including permitted medication in excess of the

maximum allowable concentration, in a horse in his care as stated in 810 KAR 8:010 Section 16 – 2. After a hearing before the Board of Judges on 7/8/2026, and considering all the evidence and testimony, the Board of Judges do find that Mr. Burton has violated 810 KAR Chapter 8. Mr. Burton is fined \$10,000 (Ten Thousand Dollars) and issued a Suspension for 365 Days from 7/22/2026 through 7/21/2027. However, considering mitigating circumstances, the Board of Judges do hold \$5,000 (Five Thousand) Dollars and 185 (One Hundred Eighty-Five) Days in abeyance if no further medication violations of Class A, B, or C occur within the date range of 1/18/2027 through 7/21/2027. If a medication violation occurs within these dates, any penalty issued will include the fine and days held in abeyance. Furthermore, #8 Giganthor is disqualified and placed 9th and the purse of \$3,500 (Three Thousand Five Hundred Dollars) is ordered to be returned and redistributed. During the first 180 days of his suspension, Mr. Leslie Burton is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing and Gaming Corporation. Entry of all horses owned or trained by Mr. Burton is denied pending transfer to persons acceptable to KHRG judges.

Status as of 7/20/2026 - Stay - Pursuant to KRS 230.320 (2) (d), Mr. Burton has been granted a stay by the President and CEO of the Kentucky Horse Racing and Gaming Corporation.

FAILURE TO APPEAR FOR A HEARING

A hearing was scheduled by the New Jersey Racing Commission ("NJRC") Board of Judges at the Meadowlands Racetrack to be held on Wednesday, April 29, 2026 to discuss Debra Dimeglio`s involvement in horses racing under the ownership listed as Canarsie Stable. A subsequent hearing was scheduled for Wednesday, May 20, 2026. In both instances Ms. Dimeglio failed to appear. The Board of Judges are in receipt of a report submitted by the New Jersey Racing Commission ("NJRC") Investigative Unit that alleges Ms. Dimeglio was listed as owner of horses racing under Canarsie Stable while an unlicensed individual was acting as owner and conducting business on behalf of the stable. The report also outlines Ms. Dimeglio`s refusal to cooperate with requests made by the NJRC Investigative Staff to provide documentation of her involvement. As a result of Ms. Dimeglio failing to cooperate with an ongoing investigation and produce the documentation that was requested by the investigative unit of the NJRC, Ms. Dimeglio is hereby issued a fine of two thousand (\$2,000.00) dollars as well as an immediate suspension of her owner`s

license. This suspension shall continue through such time that Ms. Demiglio does appear and participate at a hearing and cooperates with the ongoing investigation conducted by the NJRC. Since Ms. Dimeglio is not currently licensed by the NJRC, the suspension shall serve as a period of license ineligibility. The fine associated with this ruling must be received by the New Jersey Racing Commission on or before August 5, 2026. Violation of N.J.A.C. 13:71-2.2, N.J.A.C. 13:71-7.29 (a) 13, 14, N.J.A.C. 13:71-26.5, N.J.A.C. 13:71-26.7.

On July 20, 2026, Maryland Racing Commission personnel conducted investigative barn and truck/trailer searches at Ocean Downs. During these searches, a hypodermic needle and several syringes were discovered and confiscated belonging to trainer Mark Gray. This is in violation of COMAR 09.10.03.03.A(19)(b). As a result, Mr. Gray is hereby assessed a fine of One Thousand Dollars (\$1,000.00). Mr. Gray shall also be issued a thirty (30)-day full suspension from July 20, 2026, through and including August 18, 2026. During this suspension, both Mr. Gray and all horses owned and/or trained by him are prohibited from entering any grounds under the jurisdiction of the Maryland Racing Commission. The fine assessed must be paid within the period of the assessed suspension. Failure to submit payment within this period shall result in the full suspension of the Maryland Racing Commission licensee and will remain in effect until full payment is received.

POSITIVE TEST- POST RACE

Trainer Michael Hall was the trainer of record for the horse WISE PROFESSOR in the 12th race on April 16, 2026, at Rosecroft Raceway. Post-race analysis of urine sample #E680509 taken from WISE PROFESSOR identified the presence of 3-carboxydetomidine

at a concentration of 3.27 ng/mL $\pm$ 0.24 ng/mL. The regulatory threshold for this controlled therapeutic medication is 2 ng/mL. This was identified by the primary Maryland Racing Commission laboratory, Industrial Laboratories. At Mr. Hall's request, a split sample was sent to the Equine Integrity and Anti-Doping Sciences (EQIAS) Laboratories for confirmatory analysis. EQIAS Laboratories identified 3-carboxydetomidine in the sample at a concentration of 2.62 ng/mL $\pm$ 0.43 ng/mL, exceeding the allowable threshold. This is in violation of COMAR 09.10.03.04.B(2) and COMAR 09.10.03.04.C. As a result, Mr. Hall is hereby assessed a fine of One Thousand Dollars (\$1,000.00) and must return all purse monies. Mr. Hall shall also be issued a sixty (60)-day full suspension from July 19, 2026, through and including September 16, 2026. During this suspension, both Mr. Hall and all horses owned and/or trained by him are prohibited from entering any grounds under the jurisdiction of the Maryland Racing Commission. Additionally, WISE PROFESSOR is disqualified from first and placed ninth. The purse shall be redistributed in accordance with the official order of finish. Aggravating and mitigating factors were considered in the determination of this ruling. All purse monies must be returned within seventy-two (72) hours of this issuance. The fine assessed must be paid within the period of the assessed suspension. Failure to submit payment within this period shall result in the full suspension of the Maryland Racing Commission licensee and will remain in effect until full payment is received. Two (2) Multiple Medication Violation (MMV) points assessed.

Post-race analysis of blood sample #E652034 taken from Y'ALL GOT NO SHOT identified the presence of altrenogest (Regumate). This is in violation of COMAR 09.10.03.04.B(1) and COMAR 09.10.03.04.C. As a result, Mr. Hans is hereby assessed a fine of Five Hundred Dollars (\$500.00) and must return all purse monies. Additionally, Y'ALL GOT NO SHOT is disqualified from first and placed sixth. Trainer Licensee admits that 4-Methylaminoantipyrine was found in the blood of Gator Hanover, in the amount of approximately 0.74 ng/mL. Gator Hanover finished first in the 2nd Race at the First Tracks LLC, in Cumberland, Maine, on May 23, 2026. Trainer Licensee admits that the amounts of 4-Methylaminoantipyrine that were found in Woodmere Alvin, Gotafoolishdesire, and Gator Hanover while racing during a licensed meet constitute a violation of 01-017 C.M.R. Chapter Pursuant to 01-017 C.M. A. Therefore, a written warning, which is the recommended penalty for a Trainer Licensee's first violation of 01-017 C.M.R. Ch. 17, for the presence of a drug carrying a Class C Penalty over a 365-day period. The return of the purse winnings by all three horses named above for the violation, which was, in this case, \$6,400.00.
