POSITIVE TEST- POST RACE

Mr. Allaby was the trainer of record for his horse No Better Joy who raced at Bangor on July 19, 2026 in race # 8 and finished 2nd. The Industrial Laboratories of Denver, Colorado has notified the Maine State Harness Racing Commission that an analysis of blood sample #E718336 taken from the horse, No Better Joy at Bangor Raceway on July 19, 2026, disclosed an elevated level of Flunixin at 189 ng/mL. The elevated level of Flunixin is evidence of a violation of Commission Rule Chapter 11; therefore, this finding constitutes a positive test for the horse, No Better Joy. Mr. Allaby has agreed to a consent agreement with the MSHRC. Therefore, He has been suspended from participation for a period of 15 days 8/14/26 through 8/28/26. Mr. Allaby has been fined the amount of \$ 1,000.00, and the purse of \$ 1,325.00 has been ordered returned for redistribution. This is a full suspension.

POSITIVE TEST- POST RACE

Blood sample #935262 Collected at Northfield Park on 6/22/26 from the horse Skyway Slick was found to contain Clenbuterol at a concentration of 58+/-12 picograms per milliliter of plasma. This exceeds the regulatory threshold of 25 picograms per milliliter adopted by the OSRC. Blood sample #935262 was also found to contain Ritalinic Acid witch is a Category (A) penalty. Ms. Brewer waived her rights to a hearing, split sample and DNA. This is Ms. Brewer's first medication violation in the last 365 days. She is hereby fined \$1000.00 and suspended 365 days. Skyway Slick is disqualified and as a result of that disqualification all purse money must be returned for redistribution (\$6,000.00). If this ruling is not appealed the penalty will be reduced to a fine of \$1000.00 and a 180 days suspension and loss of purse (with 185 days stayed pending no Class 1 or Class 2 positives in the next 365 days). Aggravating factors were considered in determining this penalty. O.S.R.C.-3769-18-01(A)(1,10,13,15,16) 3769-18-02 3769-17-43. During her suspension Ms. Brewer is barred from all grounds governed by the OSRC. Any horses that she wants to transfer to another owner or trainer must be approved by the judges in Ohio or the OSRC. The fine and purse must be paid by 8/16/26. Ms. Brewer has 48 hours to appeal this ruling.

On 06/18/2026 Industrial Labs reported to the Massachusetts Gaming Commission/Racing Division, the Post Race positive report adverse analytical finding for Dexamethasone in the blood. Dexamethasone was confirmed in blood at 12.2 pg/mL. The measurement uncertainty of the method is 0.75 pg/mL at the threshold of 5 pg/mL. This is a Class 4C. Heidi Cushing was notified of the finding on 06/25/2026 and exercised her right to a split sample. The split was sent to an independent lab, Kenneth L. Maddy Equine Laboratory of California for analysis. On 08/06/2026 Kenneth L Maddy Labs sent a report confirming the initial finding of dexamethasone. Heid Cushing was notified on 08/10/2026 and waived her right to a formal hearing. As a result, Heidi Cushing is hereby fined the sum \$1,000.00. In addition, the horse TURN THE PAGE N finished 1st and is hereby disqualified. The purse monies won or \$12,500.00 is hereby forfeited and ordered returned for redistribution. The fine is payable within 48 hours of imposition. The purse monies must be returned within 10 days of ruling or before 08/20/2026.

MEDICATION PROCEDURE VIOLATION

71 IAC 5-3-2(a)(2),(b), 8-1-1.5, 8-1-2(a); 8-1-5(1),(2),(5),(8) 7Sample No. E682792 taken from the horse GW STRYKER following the conclusion of race 7 on April 22, 2026 at Hoosier Park tested positive for Furosemide (Lasix). GW STRYKER was listed as a non-Lasix horse in the program and a review of the Lasix sign-in sheet for April 22, 2026 shows that the horse did not receive Lasix from an IHRC licensed veterinarian assigned to administer Lasix on that day. As trainer of record Suhein Matos is in violation of the IHRC trainer responsibility and medication rules. Ms. Matos waived her right to split sample testing. Ms. Matos also waived her right to a hearing accepting the following penalties: For this violation Ms. Matos is fined \$500.00 which is due within seven days of this ruling. Trainer Dale Witcher was the trainer of record for the horse FLO JO in the ninth race on April 30, 2026, at Rosecroft Raceway. Post-race analysis of blood sample #E680569 taken from FLO JO identified the presence of 7-carboxycannabidiol. This finding was identified by

the primary Maryland Racing Commission laboratory, Industrial Laboratories. At Mr. Witcher's request, a split sample was sent to the University of California, Davis for confirmatory analysis. University of California, Davis also identified the presence of 7-carboxycannabidiol in the sample, confirming the original laboratory finding. This is in violation of COMAR 09.10.03.04.B(1) and COMAR 09.10.03.04.C. As a result, Mr. Witcher is hereby assessed a fine of Five Hundred Dollars (\$500.00) and must return all purse monies. Mr. Witcher shall also be issued a fifteen (15)-day full suspension from August 6, 2026, through and including August 20, 2026. During this suspension, both Mr. Witcher and all horses owned and/or trained by him are prohibited from entering any grounds under the jurisdiction of the Maryland Racing Commission. Additionally, FLO JO is disqualified from first and placed sixth. The purse shall be redistributed in accordance with the official order of finish. All purse monies must be returned within seventy-two (72) hours of this issuance. The fine assessed must be paid within the period of the assessed suspension. Failure to submit payment within this period shall result in the full suspension of the Maryland Racing Commission licensee and will remain in effect until full payment is received. Four (4) Multiple Medication Violation (MMV) points assessed.

Industrial Laboratories reported that sample #E630240 provided by the horse GREAT COMMISSION trained by Robert Wyman following its first place finish in the 17th race at the Miami County Fair (Converse) on 6/10/26 contained Theobromine, a prohibited substance in accordance with the standard used in Indiana County Fair Races as prescribed by the Indiana Horse Racing Commission Rules, 71 IAC 8-1-4.2. Robert Wyman, trainer of GREAT COMMISSION, was advised of this positive test and of his rights to split sample testing. Trainer Wyman chose to waive his right to send a split sample. The standard penalty for Theobromine is a 15-day suspension and fine of \$500 in addition to a loss of purse. It was confirmed by Sauder Feeds that the commercial feed supplement contained Cocoa Shells resulting in the Theobromine positive. After reviewing the evidence, it was found that Mr. Wyman was not culpable for the contamination. Therefore, the penalty is mitigated to "Loss of Purse." It is hereby ordered that the purse money won by GREAT COMMISSION is forfeited and redistributed among the horses according to their order of finish.
