If this ruling is not appealed, the penalty will be reduced to a \$1,000 fine with the 30-day full suspension stayed pending no further violations in the next 365 days. O.S.R.C.-3769-2-26(A)(10)&(15), 3769-17-29(A)(7), 3769-17-35. The fine must be paid by 9/24/26. Mrs. Mt Pleasant has 48 hours to appeal this ruling.

Mrs. Mt Pleasant was unprofessional and rude towards the State Veterinarian and the technician in the Test Barn after race #1 on 8/30/26. Her behavior resulted in interference affecting their ability to perform their tasks. Her hostile behavior were against the best interest of racing. Mrs. Mt Pleasant and her lawyer, Robert Farinacci, were both present for the hearing with the judges at Northfield Park on 9/13/26. After considering all testimony during the hearing, she is hereby fined \$1,000 and issued a 30-day full suspension. If this ruling is not appealed, the penalty will be reduced to a \$1,000 fine with the 30-day full suspension stayed pending no further violations in the next 365 days. O.S.R.C.-3769-2-26(A)(10)&(15) 3769-17-29(A)(10). The fine must be paid by 9/24/26. Mrs. Mt Pleasant has 48 hours to appeal this ruling.

POSITIVE TEST- PRE RACE

Brielle Roman, as trainer of record for the horse "THREE IN HEAVEN A" in the 5th race on 7/12/2026 at Vernon Downs, is issued a Sixty (60) day full suspension of her occupational license, beginning September 11, 2026, through and including November 9, 2026, and a \$1,000 fine. The pre-race blood sample collected from THREE IN HEAVEN A on 7/12/2026 tag number CV3723039 and seal number R2773700 was found to have a TCO2 concentration of 41.1 +/- 0.7 millimoles per liter. The sample was marked as containing Furosemide. This is in excess of levels established by the NYSGC. THREE IN HEAVEN A finished in 2nd place in a field of 7 and \$1875.00 in purse earnings will have to be returned and redistributed. The horse THREE IN HEAVEN A, must re-test at a permissible TCO2 level prior to being declared eligible to race. THREE IN HEAVEN A shall submit to a 6-hour pre-race detention for a period of 6 months, 8/29/2026 through 3/2/2027, without regard as to whether the horse is transferred to a new owner or trainer. The horse must also test in compliance with the above stated rules each time raced during the required pre-race detention period. During the terms of the suspension Brielle Roman is deemed a disqualified person and denied access to all grounds under the supervision of the NYSGC. Any horses owned or trained by Brielle Roman shall be denied the privilege of participating during the suspension unless transferred to another licensee approved by the Presiding Judge. (1st offense in this category). This horse did choose to have a 72-hour guarded quarantine where blood samples were periodically taken for subsequent testing by the commission. As result of such quarantine and samples, lab results showed that this horse is NOT naturally high.

Status as of 8/31/2026 - Stay - The stay of suspension has been granted but not the fine until the Commission's decision on the pending adjudication.

Industrial Laboratories reported that sample #E630438 provided by the horse KOBE'S BB trained by Leander Schwartz following its first-place finish in the second (2nd) race at the Miami County Fair (Converse) on 8/3/2026 contained Furosemide. The horse KOBE'S BB had not been declared to compete on Furosemide when entered in the race in accordance with the standard used in Indiana County Fair Races as prescribed by the Indiana Horse Racing Commission Rules, 71 IAC 8-1-4.2. Leander Schwartz, trainer of KOBE'S BB, was advised of this positive test and of his rights to split sample testing. Trainer Wyman chose to waive his right to send a split sample. The purse money won by KOBE'S BB is hereby ordered forfeited and redistributed among the horses according to their order of finish.
